## ORDER:

- 1. The RTI application is dated 16.06.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 27.07.2022 and the second appeal was filed in the Commission on 03.01.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
- 2. Shri Gurfateh Singh, Adovcate, representative of the appellant states that he has received the information today before entering the Court room and he mentions that incomplete information in relation to point number 1, 4 and 6 of the RTI application has been supplied to him.

The original affidavit be sent to the Appellant and the copy of the same be sent to the Bench for record. The representative of the appellant, Advocate, Shri Gurfateh Singh gives his consent to close the case.
