ORDER

1. This order may be read with reference to the previous order dated 29.09.2022 vide which respondent PIO to go through the RTI application and supply a fresh reply to the appellant with a copy to the Commission. Matter was adjourned for further hearing on 07.12.2022 which was preponed on the request of the appellant dated 17.10.2022, which was received in the Commission vide diary no. 23823 dated 18.10.2022 and matter was fixed for 23.11.2022 i.e. today.
2. In today's hearing, respondent, ASI, Amritpal Singh states that the reply dated 03.11.2022 has been sent to the appellant as per the directions of the Hon'ble Commission dated 29.09.2022. A copy of the same is also sent to the undersigned Bench via an email dated 03.11.2022, which is received and taken on record.

Appellant is absent in spite of registered post notice issued to her regarding preponement of hearing on her request and it is also observed no discrepancy has been pointed out by her in the supplied reply dated 03.11.2022 either to the respondent PIO or to the Commission, which means she has nothing to say in this regard.
4. With aforesaid observations, no further cause for intervention is left in this case. Hence, this instant appeal case is **disposed of and closed**. Copy of the order be sent to the parties.
