as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **9.5.2022** and Second Appeal was filed in the Commission on **11.7.2022** under Section 19 of the Right to Information Act, 2005. The case was last heard on **9.11.2022**.

- 2. The appellant is absent without intimation for the second successive hearing. The Respondent PIO represented by Smt. Sukhmanmeet Kaur, Building Inspector, has submitted a copy of a reply sent to the appellant vide Letter No. 357-58/Bld. Dated 12.5.2022, wherein he was informed that his RTI application was in the form of questions and so cannot be addressed as per the RTI Act.
- 3. The Commission has examined the reply alongside the RTI application and upholds the PIO's decision. This Appeal is accordingly **Disposed of**.
