as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **9.5.2022** and Second Appeal was filed in the Commission on **11.7.2022** under Section 19 of the Right to Information Act, 2005. The case was last heard on **9.11.2022**.

2. The appellant is absent without intimation for the second successive hearing. The Respondent PIO represented by Smt. Sukhmanmeet Kaur, Building Inspector, has submitted a copy of a reply sent to the appellant vide Letter No. 357-58/Bld. Dated 12.5.2022, wherein he was informed that his RTI application was in the form of questions and so cannot be addressed as per the RTI Act.

3. The Commission has examined the reply alongside the RTI application and upholds the PIO's decision. This Appeal is accordingly **Disposed of**.
