ORDER:

1. The RTI application dated 07.10.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 14.11.2022 and second appeal was filed in the Commission on 03.01.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. Notice of hearing was issued to the parties for hearing through CISCO WEBEX on 10.05.2023 at 11.00 a.m. i.e. today.
3. In today's hearing, the appellant states that he has already deposited Rs.370/- to the concerned department but information is supplied without attestation, without page numbering. He adds that an email dated 09.05.2023 is sent in this regard, which is received by the undersigned Bench and taken on record.
4. The respondent, Sh. Balkesh Sharma, XEN states that the information as available in their record has been supplied to the appellant.
5. After discussing with the parties and examining the case file, appellant is advised to visit the respondent's office for inspection of the official record on **16.05.2023 at 11.30 AM**. The respondent PIO is directed to be present on the fixed date and time and show the record to the appellant as per RTI application. He is also directed to supply the attested copy of identified information after inspection within seven days as per RTI application under intimation to the Commission.
6. Both the parties are advised to represent this case in person through cisco webex meetings software on the next date of hearing, failing which, appropriate order in their absence shall be passed.
7. With the aforesaid directions, **the matter is adjourned for further hearing on 30.08.2023 at 11:00 A.M. through CISCO-Webex (Video Conferencing application)**. Copy of the order be sent to the parties.
