ORDER

1. This order may be read with reference to the order dated 20.09.2022 passed by this Bench on the previous hearing, as the hearing scheduled for 31.10.2022 was postponed.
2. The case has been heard today. Shri Ajay Sharma comes present to attend the hearing on behalf of the appellant through cisco webex.
3. Shri Narinder Singh, Clerk O/o GLADA, Ludhiana comes present to attend the hearing in person before the Bench and states that reply to RTI application of the appellant has been given on 24.05.2022, 22.06.2022, 12.07.2022 and then on 28.09.2022 apprising the appellant that the colony New Kitchlu Nagar has not been regularized.
4. The representative of appellant Shri Ajay Sharma states that the appellant does not agree with the contention of PIO and states that a receipt for cash deposited has been issued by GLADA in respect of that colony and it is not correct that this colony does not come within jurisdiction of GLADA.
5. On the asking of the Bench, the respondent clarifies that the colonizer has applied for regularization by depositing fee.
6. Post deliberations, the Bench directs the PIO O/o GLADA, Ludhiana to file an affidavit on e-stamp paper, within 21 (Twenty one) days, duly signed by the PIO and attested by the Notary Public to the

effect that the information as available in official records in AC No.3276/2022 has been supplied to the appellant. It be further stated that the colony New Kitchlu Nagar has not been regularized and the said colonizer has applied for regularization. It be further stated that nothing has been concealed therein and the statement made is true and correct. Original affidavit be sent to the appellant and copy of the same be sent to the Commission for record.

7. With the aforesaid directions, the instant appeal case is disposed off and closed. Copies of the order be sent to the concerned parties.
