ORDER:

*(To be read in continuity with earlier orders on 9.11.2022)*

1. The RTI application is dated **4.5.2022** vide which the appellant has sought information **regarding the DSP Nabha's report to the SSP Patiala etc.,** as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **13.5.2022** and Second Appeal was filed in the Commission on **15.7.2022** under Section 19 of the Right to Information Act, 2005. The case was last heard on **9.11.2022**.
2. Both parties are present. The respondent PIO, represented by ASI, Gursewak Singh, PS Kotwali Nabha, on behalf of DSP, Nabha and Sh. Amandeep Singh, Senior Assistant from the office of SSP, Patiala. The PIO-cum-DSP, Sh. Davinder Singh Attri was issued a Show Cause Notice and directed to attend today's hearing in person. The PIO-cum-DSP, Sh. Davinder Singh Attri has not only failed to appear in person, he has neither deemed it appropriate to submit any written reply to the Show Cause Notice.
3. The Commission grants the **PIO-cum-DSP, Sh. Davinder Singh Attri**, one final opportunity to comply with this Commission's directions and submit a written reply to the Show Cause Notice issued to him via this Commission's Order of 9.11.2022 and present himself at the next hearing of this Appeal Case. PIO-cum-DSP, is further directed to submit a pointwise reply to the RTI application by way of a duly **notarized affidavit (on e-stamp paper)** along with attested copies of the information requested in the said RTI application. Any further failure to comply and the Commission will be compelled to invoke the strictest penalties available in the provisions of the RTI Act, 2005.
