**ORDER:**

1. The RTI application is dated 25.05.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 25.06.2022 and the second appeal was filed in the Commission on 04.01.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The notice of hearing was issued to the parties for 15.03.2023. Accordingly, the case has been heard today. The appellant has not come present to attend the hearing in person before the Bench or through cisco webex nor any intimation has been given by him in this regard.
3. Shri Pawan Kumar, SDO-Public Health O/o JDA, Jalandhar has come present to attend the hearing through cisco webex. He states that RTI application of the appellant has been received from the O/o PUDA, Mohali yesterday. He further adds that reply has already been given to the appellant through online portal on 07.07.2022 by the Chief Administrator, PUDA, Jalandhar-cum-First Appellate Authority.
4. The appellant is contacted on his mobile phone. He is apprised of the version of PIO O/o JDA, Jalandhar. He states that he has not received any reply from the FAA. He is then apprised that the grievance raised by him has been resolved and the updated status is available online.
5. Post deliberations, the respondent O/o JDA, Jalandhar is directed to send hard copy of the reply to the appellant through registered post with a copy to the Commission within one week. The respondent gives assurance for the same.
