**ORDER:**

1. The RTI application is dated 14.10.2022 vide which the appellant has sought information as enumerated in her RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 15.11.2022 and the second appeal was filed in the Commission on 04.01.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The notice of hearing was issued to the parties for 15.03.2023. Accordingly, the case has been heard today. The appellant has not come present to attend the hearing in person before the Bench or through cisco webex nor any intimation has been given by him in this regard. The perusal of the case file shows that notice of hearing has been received back undelivered with the remarks of the postal department that the address of the appellant is incomplete.
3. Shri Tarun, Clerk O/o GLADA, Ludhiana comes present to attend the hearing through cisco webex. He states that the RTI application of the appellant has been received yesterday from the O/o PUDA, Mohali hence has requested for additional time to provide the information to the appellant.
4. The request of the respondent is acceded to. The PIO is directed to ensure to send point-wise information to the appellant before the next hearing as also ensure to come present in person before the Bench on the next hearing, failing which penal consequences shall follow. The appellant is also advised to come present in person on the next hearing
