1. The RTI application is dated 16.4.2021 vide which the appellant has sought information as:-

C. Particulars of Information Required: The information against the below mentioned points are called duly certified. The points of information are detailed below:
A) Certified copy of the complete file and recommendation against which the vacancy for the English typist was floated/called in year 2017 and year 2008 (either through publication or through District Employment Exchange) and the interview and selection exam was kept in year 2007 and year 2008 for the said post/vacancy.
B) Certified copy of the detailed list duly certified of the candidates who appeared and were called for the post of English typist for year 2007 and year 2008. Also supply the copy of the result of the typing speed test occurred with complete detail of the participants who took place and were marked as qualified. Also supply the detailed list of the candidates who appeared in the interview and to whom the appointment letters were issued/granted.

enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **20.5.2021** and Second Appeal was filed in the Commission on **20.7.2021** under Section 19 of the Right to Information Act 2005. The case was last heard on **4.8.2022**.

2. The appellant is absent without intimation. As directed by the Commission at the last hearing on 4.8.2022, the appellant was invited to inspect the record in the office of the PIO on 9.8.2022, with regard to the any information regarding any recruitment to the post of Steno Typist in the year 2007-08, as cited in the RTI application. At the last hearing, the appellant was also requested to provide any specific reference to any advertisement for General / Schedule Caste and / or Backward Class candidates for the year 2007-08.
