ORDER

1. This order may be read with the reference to the previous order dated 11.10.2022.
2. The case has been heard today in the Commission's office at Chandigarh. Shri Gurpartap Singh, AEE, states that the information has been sent to Shri Amarjit Singh Dhamotia, appellant twice i.e. through speed post vide letter dated 28.07.2022 as well as by hand but the appellant is not satisfied as per the comments written by him at the bottom of the letter dated 28.07.2022. He further submits a copy of reply vide letter number 8173 dated 28.07.2022 (along with annexures) to the Bench, which is taken on record.
3. Shri Amarjit Singh Dhamotia, appellant is not present today before the Bench or through cisco webex. During the hearing, a call is made to Shri Amarjit Singh Dhamotia, appellant but his phone is unreachable. An email dated 10.11.2022 has been sent to the bench in which the appellant has requested for an exemption from today's hearing due to his health issues and further written that no information has been supplied to him.
4. Post deliberations and after going through the case file and the documents placed on record, the Bench observes that satisfactory reply in accordance to the rule position of the Government has been filed by the PIO in this case. Also, considering the verbal statements given by Shri Gurpartap Singh, AEE, the Bench **drops** the show cause notice which was issued to the PIO. So, no further cause for intervention is left in this case.
5. **This case is disposed off and closed.** Copies of the order be sent to the concerned parties.
