1. The RTI application is dated 21.10.2021 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 13.12.2021 and the second appeal was filed in the Commission on 05.01.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
