ORDER

1. The RTI application is dated 08.03.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereafter FAA) on 15.07.2022 and second appeal was filed in the Commission on 04.02.2022 under Section 19 of the Right to Information Act, 2005 (hereafter RTI Act).
2. Notice of hearing was issued to the parties for hearing on 02.11.2022 through CISCO WEBEX i.e. today.
3. In today's hearing, both the parties are present.
4. Appellant states that he has filed RTI application on 08.03.2022 and respondent PIO transferring application to the respondent PIO, O/o Directorate Technical Education wing on 29.03.2022 but nothing is received even after that. He adds that reminders were sent to the First Appellate Authority through email but no response. He further mentions that partial information is supplied to him in connection with point no. 4.
5. Respondent, Sh. Harpreet Singh states that concerned respondent office intimates that required record is not available as per official record. He further requests for an adjournment in this case approximately for 10 days.
6. After having detailed discussion with both the parties, respondent PIO is directed to supply the point-wise information/reply as per RTI application to the appellant within fifteen days from today along with directions to represent this case on the next date of hearing positively.
7. Appellant is also advised to point out ambiguity, if any, specifically as per RTI application, in writing to the respondent PIO with a copy to the Commission, within seven days after receipt of information, failing which it will be presumed that he has nothing to say in this regard and case will be decided on merits.
8. To come up on **18.01.2023 at 11:00 A.M. through CISCO-Webex** (Video Conferencing application). Copy of the order be sent to the parties.
