## ORDER

- 1. The RTI application is dated 08.03.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereafter FAA) on 15.07.2022 and second appeal was filed in the Commission on 04.02.2022 under Section 19 of the Right to Information Act, 2005 (hereafter RTI Act).

- After having detailed discussion with both the parties, respondent PIO is directed to supply
  the point-wise information/reply as per RTI application to the appellant within fifteen days
