## ORDER

- 1. The RTI application is dated 08.03.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereafter FAA) on 15.07.2022 and second appeal was filed in the Commission on 04.02.2022 under Section 19 of the Right to Information Act, 2005 (hereafter RTI Act).

Respondent PIO, Directorate of Techincal Education & Industrial Training, Punjab is directed to supply the point-wise information/reply as per RTI application except point no. 4 to the appellant within fifteen days from today along with directions to represent this case on the next date of hearing positively.
- 8. Appellant is also advised to point out ambiguity, if any, specifically as per RTI application, in writing to the respondent PIO with a copy to the Commission, within seven days after receipt of information, failing which it will be presumed that he has nothing to say in this regard and case will be decided on merits.
