1. The RTI application is dated 28.4.2022 vide which the appellant has sought information:

Reference to above mentioned building of Amarson Polymer at Mushtaq Gung near Sufian Chowk Ludhiana

Reference to above mentioned building of Amarson Polymer at Mushtaq Gung near Suttan Chowk Luanian owned by Mr.Inderjeet Singh Gola got engulfed by a massive fire in November 2017 resulting of 16 persons died during rescue operation including 9 Firemen
Police has registered a FIR u/s IPCs 285/304A/337/338/427 etc.

Building having illegal/non compoundable construction by the owner as the MCL was in sleeping mode before the fire incident November 2017 and I may be provided the information under RTI Act of 2005 as under:

- That I may be provided certified/legible copy of approved plan of building owned by Inder Singh Gola
 at Mushtaq Gunj near Sufian Chowk before the fire November 2017 or earlier date
- That I may be provided certified/legible copy of Challan/Notice dated 05,03,2015 issued by MCL to owner Inderject Singh Gola for illegal/unathorized construction including the assessment sheets and G-8 receipt for the amount deposited
- That I may be provided certified/legible copy of Final demolishing order and action taken to the building to owner Inderject Singh Gola for illegal/unathorized construction and action in lieu of demolishing orders.
- 4. That I may be provided certified/legible copy of approved plan of building owned by Inder Singh Gola at Mushtag Gunj near Sufian Chowk after the fire i.e. after November 2017
- That I may be provided certified/legible certified copy of the Challan/notice issued to the owner of the Building Mr. Inderjeet Singh Gola as he started the construction again before the approval of the plans.
- That I may be provided certified/legible certified copy of 6-8 receipt for depositing the previous payment against the challan before the November 2017

as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **31.5.2022** and Second Appeal was filed in the Commission on **18.7.2022** under Section 19 of the Right to Information Act, 2005. The case was last heard on **10.11.2022**.
