# **ORDER**

- 1. This order may be read with the reference to the order dated 10.11.2022 passed by this Bench on the previous hearing.
- 2. The case has been heard today in the Commission's office at Chandigarh. Shri Surinder Singh Saini, appellant comes present to attend the hearing through cisco webex.
- 3. Shri Pankaj Lehri, Junior Engineer, Sub Division, PSPCL, Sarna (Pathankot) comes present to attend the hearing on behalf of the PIO through cisco webex. He states that in coordination with the appellant, a spot visit was made and that information as available in the official records has been supplied to the appellant.
- 4. On asking of the Bench, the appellant admits spot visit by PSPCL official, however, shows his dissatisfaction about the information supplied and denies that inspection of records was got done. He states that the grievance raised by him in his RTI application still subsists.
- 5. The respondent states that issues raised by the appellant in his RTI will be resolved and that regarding the grievance of appellant, the appellant has also been assured by the SDO Shri Bodh Raj to redress the same when he met him on 30.01.2023.
- 6. The Bench now, directs the PIO to file an affidavit on e-stamp paper within 21 (Twenty one) days, duly signed by the PIO and attested by the Notary Public to the effect that the information as available in the official records in AC No.3362/2022 has been supplied to the appellant. The Information provided is true and correct. It be further stated that with regard to the grievance raised by the appellant, the same will be redressed as assured to him by Shri Bodh Raj, SDO Sub Division, PSPCL, Sarna. Original affidavit be sent to the appellant and copy of the same be sent to the Commission for record.
- 7. With the aforesaid directions, **the instant appeal case is disposed off and closed.** Copies of the order be sent to the concerned parties.
