Point No. 7:- Whether the said project as mentioned in the query no 1 and 2, registered/applied under RERA. If yes Please provide the copies (including file notings) as available on the above stated subject matter in the shape of scanned copies in a D.V.D.

Point No. 8:- Whether the said project as mentioned in the query no 1 and 2, registered/applied under RERA. If yes Please provide the certified copies (including file notings) as available on the above stated subject matter.

Point No. 9:- If the answers as well as the documents are received by the applicant, within a span of 7 days, from the date of dispatch of the present application, there is no requirement of giving answers to Point No. 3 to Point No. 8.

Point No. 10:- If the information does not relate to the Department kindly transfer the Application to the concerned department within a period of 5 days.
