- Appellant, Sh. Inderjit Singh stated that partial information has been supplied so far by the respondent authority i.e. information pertaining to point no. 1, 2,3,6,7 is still pending. On this respondent, Sh. Jatinder Sahi contended that requisite information has already been furnished to the appellant except the points which relates to third party which is exempted u/s RTI Act 2005.

4. In the view of above, the Commission has decided to adjourn the matter. Further, in order to bring the whole controversy to an end and so as to deal the case more effectively the matter is adjourned to the personal hearing at PSIC, Chandigarh on 23rd, january, 2022 at 11.30 A.M.

Another opportunity is given to both the parties to present the case on next date of hearing positively and also to justify their claim, failing to which the case would be decided on merit basis.
