3. Appellant, Sh. Inderjit Singh stated that partial information has been supplied so far by the respondent authority i.e. information pertaining to point no. 1, 2,3,6,7 is still pending. Jatinder Sahi contended that requisite information has already been furnished to the appellant except the points which relates to third party which is exempted u/s RTI Act 2005.
