ORDER:

1. The RTI application is dated **19.8.2016** vide which the appellant has sought information **regarding online complaint to the Deputy CM**, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **31.8.2021** and Second Appeal was filed in the Commission on **29.7.2022** under Section 19 of the Right to Information Act, 2005. 3. Noting, that even though this RTI application was submitted on 19.8.2016, the First Appeal was filed only on 31.8.2021 and the Second Appeal to the Commission has been filed on 28.10.2022. Accordingly, the respondent PIO is granted 30 days from the date of this hearing to provide a fresh, pointwise reply to the RTI application along with all the requested information by way of duly attested copies. Failure to comply with this Commission's direction, shall invite penal action as per the RTI Act, 2005.
