	(3) Certified Copy of yellow TP sheet which has no mention of breadth of street as mentioned in report of ATP as demanded in para no. 1.
	(4) Provide copy of sale deed of property No. BIX/1248 Gali Rupa Mistri, Ludhiana measuring 56 Sq yards which has no mention breadth of street as referred to in report dated 20/4/2021 by ATP Ludhiana.
	(5) Provide present status of building of property No. BIX/1248 Gali Rupa Mistri, Ludhiana giving height of building and number of floors of building now constructed.
	(6) Provide name of Building under whose nose building has been constructed.
	(7) Provide certified copies of all the notices or certificates or any other documents issued in relation to the building during last three years from 30/8/2021 and any other reply received by the department.

as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **11.10.2021** and Second Appeal was filed in the Commission on **27.7.2022** under Section 19 of the Right to Information Act, 2005. The case was last heard on **10.11.2022**.

Appeal Case No. 3502 of 2022 (Video Conference Proceedings)

2. Both parties are present. The appellant has joined this hearing via Video Conference despite the Commission's direction (on 10.11.2022) to attend this hearing in person at Chandigarh.
