ORDER:

1. This case may be read with the reference to the previous order dated 13.04.2023.

- 2. In today's hearing, the appellant states that the status of the case is same, as it was on the previous hearing held on 13.04.2023. He adds that a letter dated 26.08.2022 was sent to the Commission via email dated 30.08.2022, which was received and on record in the case file.
- 3. Respondent PIO-cum-EO, Sh. Vipin Kumar states that the information has been sent to the appellant on 22.02.2021 (26 pages) and copy of the two covering letters were also sent to the Commission, which were received vide diary no. 6914 and 6915 dated 25.03.2021 and are taken on record. He further adds that another reply dated 31.08.2022 was also sent to the appellant with a copy to the Commission vide letter no. 1750 dated 31.08.2022, which is received in the Commission vide diary number 20442 dated 08.09.2022 and taken on record. Respondent PIO also adds that whatever was available in the official record had already been supplied and nothing is left to be supplied. He also requests to drop the show cause notice issued to him by name vide order dated 13.04.2023.
- 4. After discussing with both the parties in detail, it is observed that available information had already been supplied to the appellant but appellant is dissatisfied with the partial supplied information. Accordingly, respondent PIO concerned is directed to supply an affidavit in original duly attested by him to the appellant within ten days after receipt of this order with a copy to the Commission. Show cause notice is <u>dropped</u> which was issued to the respondent PIO vide order dated 13.04.2023.
