## **ORDER(Second hearing):**

- 1. This order may be read with the reference of previous order of the Commission dated 12.12.2022.
- 2. Appellant, Sh. Nirbhai Singh Sidhu stated that no information has been supplied to him by the respondent authority.
- 3. This Commission, takes notes that this RTI application has been pending since 05.05.2022 without any response from the respondent. The respondent PIO is herewith issued a Show Cause Notice. The respondent PIO is herewith ordered to SHOW CAUSE as to why a penalty should not be imposed upon him under Section 20 (1) of RTI Act, 2005, for causing willful delay/denial of the information requested by the appellant.

"In addition to the written reply, the respondent PIO is also given an opportunity under Section 20 (1) provision there to, for a personal hearing before the imposition of such penalty on the next date of hearing. He may take note that in case he does not file his written reply and does not avail himself of the opportunity of personal hearing on the date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex parte."

- 4. Meanwhile, in view of the harassment and detriment caused to the appellant, Sh. Nirbhai Singh Sidhu, this Commission deems it appropriate to award a compensation of Rupees Ten Thousand (Rs. 10000.00). This is to be paid by the Public Authority, within 20 days of receiving this order.
- 5. To come up on 14.06.2023 through personal hearing at PSIC Chandigarh timing 11:30 am.
