ORDER:

1. This case may be read with the reference of the previous order dated 09.02.2023.
2. In today's hearing, the Appellant, Sh. Joga Singh states that ਜਮਾਂਬੰਦੀ ਸਾਲ 1963-64 is received and rest are pending as per the previous order of the Commission dated 09.02.2023. He submits a letter dated 11.04.2023 through which he authorized Sh. Kuldeep Singh to represent his case in his absence, which is taken on record.
3. The respondent, Sh. Balkar Singh states that the partial information has been supplied to the appellant and rest of the information is at the office of Patwari.
4. After discussing with both the parties, the appellant, Sh. Joga Singh along with his representative is directed to visit the concerned office on 17.04.2023 (Monday) at 11 a.m. and meet the concerned PIO / officials for collecting the record after inspecting the same as per his RTI.
5. The PIO and other concerned officials including concerned Patwari are directed to be there at the time of inspection on the said date and time on the Appellant's visit. The PIO is also directed to supply the pending information to the Appellant by hand or send the specific identified record to the Appellant within seven days from the date of inspection in connection with ਜਮਾਂਬੰਦੀਆਂ ਸਾਲ 1961-62, 1962-63, 1965-66 ਅਤੇ ਜਮਾਂਬੰਦੀ ਹੈਜਾ ਮੁਫਸਲ, failing which stern action would be initiated against the concerned respondent PIO.
6. If the Appellant, Shri Joga Singh or his representative will not visit for inspection on the said date and time then it would be presumed that he does not require the information anymore and the case will be decided on merits.
7. **Matter is adjourned for further hearing on 19.07.2023 at 11:00 A.M. through CISCO WEBEX.** Copy of the order be sent to the parties.
