## **ORDER:**

- 1. The RTI application is dated 12.10.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 18.11.2022 and the second appeal was filed in the Commission on 04.01.2023under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
- 2. The notice of hearing was issued to the parties for 15.03.2023. Accordingly, the case has been heard today. Shri Chaand Singh, the appellant comes present to attend the hearing in person before the Bench and states that partial information has been given by the PIO. He requests that his requirement will be fulfilled if the affidavit would be supplied to him by the PIO in this appeal case.
- 3. Shri Tejvinder Singh, Employment Officer-cum-PIO has come present to attend the hearing before the Bench in person and files written reply mentioning therein that appellant has sought information on seven points and complete information has been sent to him vide letter dated 11.11.2022 and 19.12.2022 by registered post and again by email dated 07.03.2023. Each point of the RTI application of the appellant has been addressed as per information available in official records. Copy of the reply is taken on record.
- 4. In view of the aforesaid discussion and examining the document brought along by the respondent, the Bench finds them in order. The notified PIO is now directed to file an affidavit on e-stamp paper within twenty one days(21 days) duly signed by the PIO and attested by the Notary Public to the effect that the information as available in the official records in AC No.361 of 2023 has been provided to the appellant. It be further stated that nothing has been concealed therein and the statement made is true and correct. Original affidavit be sent to the appellant and copy of the same be sent to the Commission for record.
- 5. With the aforesaid directions, **the instant appeal case is disposed off and closed.** Copies of the order be sent to the concerned parties.
