ORDER:

- 1. The RTI application is dated **20.4.2022** vide which the appellant has sought information <u>regarding Letter No. 457/M</u>, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **21.6.2022** and Second Appeal was filed in the Commission on **4.8.2022** under Section 19 of the Right to Information Act, 2005. Notice was issued to the parties for first hearing in the Commission on **3.11.2022**.
- 2. Both parties are present. The respondent PIO, represented by Sh. Jasbir Singh, Reader to XEN is present. As per the respondent, the information has already been provided to the appellant vide Letter No. 3662 Dated 18.5.2022 by registered post. The appellant however, states that said reply contains no information regarding Letter No. 457/M Dated 26.12.2022 from XEN Harike, Canal Division, as cited in his RTI application. The respondent representing XEN Harike Canal Division, explained that a letter was received from SDO, Sub Division vide Letter No. 396 Dated 2.12.2019, on which, Letter No. 457/M Dated 26.12.2019 was written to Superintendent Engineer, Ferozepur Canal Circle for further action. The Commission notes that this RTI application originally addressed to the Superintendent Engineer, Ferozepur Canal Circle, who has provided no reply/information to the appellant till date.
- 3. In view of the above, this Commission deems it fit to serve this Show Cause Notice to the PIO, office of Superintendent Engineer, Ferozepur, Canal Circle, Ferozepur.
- 4. The respondent <u>PIO, office of Superintendent Engineer, Ferozepur, Canal Circle, Ferozepur</u>, is herewith ordered to **SHOW CAUSE** as to why a penalty should not be imposed upon him under Section 20 (1) of RTI Act, 2005, for causing willful delay/denial of the information requested by the appellant as far back as on **20.4.2022**.
