ORDER:

1. The RTI application is dated **21.5.2022** vide which the appellant sought the following:

as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **9.7.2022** and Second Appeal was filed in the Commission on **5.8.2022** under Section 19 of the Right to Information Act, 2005. Notice was issued to the parties for first hearing in the Commission on **26.10.2022**.

- 2. Both parties are present. The respondent PIO, represented by Bittu, SA, states that a reply was sent to the appellant vide Letter No. 5319 Dated 28.6.2022, wherein the information pertaining to point no. 2 was supplied but the NOC sought at point no. 1 was not available and the appellant was accordingly intimated.
- 3. After deliberations at this hearing, the PIO is directed to provide the available record pertaining to acquisition land of Mandi cited in the RTI application along with any other relevant document by way of the Notification etc. within 20 days of receipt of this Order.
