## <u>ORDER</u>

1. This order may be read with the reference to the previous order dated 17.10.2022.

2. The case has been heard today in the Commission's office at Chandigarh. Shri Jagtar Singh,

3. Shri Rajinder Kumar, Panchayat Secretary states that he has brought the information in the Court.

It be further stated that nothing has been concealed therein and the information supplied to the Appellant is true and correct. The original affidavit must be sent to the Appellant and the copy of the same be sent to the bench of undersigned.
