**ORDER**

1. The RTI application is dated 14.5.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 25.6.2022 and second appeal was filed in the Commission on 5.8.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). Notice of hearing was issued to the parties for hearing through CISCO WEBEX on 9.11.2022 and further postponed to 9.2.2023 at 11.00 a.m.
2. In today's hearing, both the parties are present.
3. The appellant states that as per his RTI application an information with regard to an enquiry of complaint made by him was to be done by the DC, Kapurthala, which was to be provided but nothing has been received in this regard.
4. The respondent states that reply was sent to the appellant vide letter dated 04.11.2022 stating therein that enquiry in the complaint has not been done and matter was filed on the facts, which the appellant denies to receive. She adds that reply was also sent to the Commission vide letter no. 22562 dated 04.11.2022, which is received vide diary no. 26286 dated 15.11.2022, which is taken on record.
5. After hearing the parties in detail, the respondent PIO is directed to supply an affidavit in original as per queries raised by the appellant in his RTI application duly attested by the competent authority within seven days after receipt of this order, to the appellant with a copy to the Commission. **A copy of this order be also sent to Ms. Kulwinder Kaur (Superintendent-cum-PIO) by name through registered post for her ready reference.**
