## ORDER:

1. The RTI application is dated 9.3.2022 vide which the appellant has sought information as under:-

enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on 20.4.2022 and Second Appeal was filed in the Commission on 5.8.2022 under Section 19 of the Right to Information Act, 2005. Notice was issued to the parties for first hearing in the Commission on 20.10.2022.

2. Both parties are present. The respondent PIO, represented by Amit Kumar, Clerk from the Property Tax Department, has submitted a copy of the reply sent to the appellant vide Letter No. 246/PTD dated 14.10.2022, whereby the information was conveyed to him.
