ORDER:

- This order may be read with reference to the previous order dated 15.11.2022 vide which
  respondent PIO was absent but an email dated 13.09.2022 was received stating therein that
  information was sent to the appellant vide letter no. 1214 dated 07.06.2022 but appellant

- 3. Respondent PIO is absent consequently second time in spite of registered notices/orders issued to him by the Commission, which means he has causal approach towards the directions of the Commission.
- 4. In view of the foregoing, <u>respondent PIO, O/o Secy.</u>, <u>Regional Transport Authority, Faridkot is directed to show cause</u> in writing or through affidavit under Section 20(1) of the RTI Act, as to why penalty be not imposed upon him for willful delay/ denial of the information to the RTI applicant and why the compensation be not awarded to the complainant under Section 19 (8)(b) of the Act for detriment suffered.

In addition to his submission, the PIO is also hereby given an opportunity under Section 20(1) proviso, thereto, for a personal hearing before the imposition of such penalty on the next date of hearing. He may note that in case he does not file his submission and does not avail himself of the opportunity of personal hearing on the next date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him exparte.
