**ORDER:**

1. The RTI application is dated 10.05.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 18.06.2022 and second appeal was filed in the Commission on 09.08.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. Notice of hearing was issued to the parties for hearing through CISCO WEBEX on 15.11.2022 i.e. today.
3. In today's hearing, appellant states that information is still pending from the respondent PIO.
4. Respondent, Sh. Darshan Singh states that demanded information is 45 years old, which is not traceable till today. He adds that record will be supplied once it will be traced and a reply in this regard had already been supplied to the appellant.
5. After having detailed discussion with both the parties and examining the case file, it is observed that respondent, Sh. Darshan Singh (SA) is giving a vague statement during the hearing that record will be supplied once it will be traced.

Accordingly, respondent PIO is directed to speed up efforts for the tracing the record and supply it to the appellant within fifteen days after receipt of this order, under intimation to the Commission. A copy of this order be sent to him by name through registered post for his ready reference.

6. Both the parties are advised to represent this case on the next date of hearing positively, failing which case will be decided on merit basis.
7. To come up on **05.01.2023 at 11:00 A.M. through CISCO-Webex** (Video Conferencing application). Copy of the order be sent to the parties.
