ORDER:

- 1. This order may be read with reference to the order dated 29.05.2023 passed by this Bench on the previous hearing.

The PIO-Tehsildar, Revenue Department Khanna, District Ludhiana and PIO-GLADA, Ludhiana are impleaded in the case as Respondent No.2 & 3 and directed to provide point-wise information to the appellant before the next hearing. The PIO O/o GLADA Ludhiana and PIO-Tehsildar Revenue Department, Khanna are directed to come present in person before the Bench to attend the next hearing.
- 5. With the aforesaid directions, the **matter is adjourned**. Since I am demitting the office on 4th August 2023 and I am left with little time to hear the case further, this case file is sent to the Deputy Registrar to place this case file before the Hon'ble Chief Information Commissioner for re-allocation of the instant appeal case. PIO-PUDA is exempted from further appearance.
