ORDER:

1. This order may be read with reference to the previous order dated 10.11.2022 vide which respondent, Ms. Kulwinder Kaur stated that information was sent to the appellant 15 minutes ago via email, which quite obvious not gone through by the appellant. Respondent PIO was directed to send the information today through registered post to the appellant under intimation to the Commission. Matter was adjourned for further hearing on 14.02.2023 i.e. today.
2. In today's hearing, appellant intimates the Commission that online portal is mentioned in the supplied reply (received on 16.11.2022) but requisite information is not available on the said portal. He further adds that similar kind of information had already been supplied by the ferozepur office.
3. On this, respondent, Sh. Sanjeev Garg states that he is presenting this case first time before the undersigned Bench and intimates the Commission that reply was sent to the appellant on 07.11.2022. He also mentions that requisite information contain personal information of the appellant which could not be supplied as per RTI Act, 2005.
4. After discussing with both the parties and examining the case file, inspection of the official record by the appellant as per RTI application is fixed for 20.02.2023 at 11:00 AM at the respondent office and respondent PIO is directed to supply the information except personal information which is exempted as per RTI act, 2005 on the appellant's visit.
5. Respondent, Sh. Sanjeev Garg is directed to be present during the appellant's visit. In case he is not available then duty of other official may be ensured.
6. Both the parties are advised to represent this case in person on the next date of hearing, failing to which, appropriate order in their absence shall be passed.
7. To come up on **19.04.2023 at 11:00 A.M. through CISCO-Webex** (Video Conferencing application). Copy of the order be sent to the parties.
