ORDER

1. This case may be read with the reference to the previous order dated 24.11.2022.
2. The case has been heard today in the Commission's office at Chandigarh. Shri Ashwani Kumar, appellant states an affidavit which has been given to him is not proper and is not according to the previous order dated 24.11.2022, which was passed by the Bench. He further mentions about a letter dated 28.11.2022, which has been sent to the Bench; which is seen and taken on record.
3. On further asking the respondent, Ms. Rohini, Building Inspector states that the official record is kept in the department as per date and file number and they have no objection if the appellant wants to inspect the official record related to his RTI application.
4. Post deliberations, the Bench directs the PIO concerned to call the appellant to the concerned office and supply the information to the appellant as per his RTI application after getting case related details like case number and file number from the appellant. In case complete information is not available with them then the PIO is directed to file an affidavit on e- stamp paper duly signed by the PIO; and attested by the Notary Public to the effect that the information as available in the official record stands supplied. The PIO should further state that nothing has been concealed therein. The above statement is true and correct. The original affidavit be sent to the Appellant and a copy of the same be sent to the bench of undersigned for record.
5. With the aforesaid directions, the matter is adjourned. **Both the concerned parties are directed to come up for hearing on 03.01.2023 at 11.30 AM before the Bench at Punjab State Information Commission, Sector 16, Chandigarh.** Copies of the order be sent to the concerned parties.
