**ORDER:**

1. The RTI application is dated 15.11.2021 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 2.2.2022 and second appeal was filed in the Commission on 16.8.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). Notice of hearing was issued to the parties for hearing through CISCO WEBEX on 10.11.2022 i.e. today
2. In today's hearing, both the parties are present.
3. Respondent, Sh. Charanjeet Singh states that information had already been supplied to the appellant but appellant denies on the same. Appellant intimates the Commission that information is still pending from the respondent PIO as per RTI application.
4. After discussing with both the parties in detail, appellant is advised to visit the respondent's office tomorrow at 10:30 am to inspect the official record and obtain the information; and the respondent PIO shall provide copies thereof, according to his RTI application, within seven days, in accordance with the relevant provisions of the RTI Act, 2005.
5. Both the parties are advised to represent this case in person on the next date of hearing, failing to which, appropriate order in their absence shall be passed.
6. To come up on **15.12.2022 at 11:00 A.M. through CISCO-Webex** (Video Conferencing application). Copy of the order be sent to the parties.
