- 5. While discussing with the parties, respondent, Sh. Jaspal Singh also clarifies that the information is voluminous and can only be gathered from NIC office.
- 6. In view of above, a final opportunity is given to the respondent PIO to supply the point wise reply / information after collecting the same from the concerned office i.e. NIC as per the respondent (except personal information like adhar card or bank details etc.) as per RTI application, to the Appellant within 15 days from today.
- 7. Appellant is advised to go through the information, once he had received and point out discrepancy within seven days in writing to the respondent PIO with a copy to the Commission, failing which it will be presumed that he has nothing to say in this regard.
- 8. With the aforesaid directions, the matter is adjourned for further hearing on 27.04.2023 at 11:00 A.M. at Punjab State Information Commission, Sector 16, Madhya Marg, Chandigarh. Copy of the order be sent to the parties.
