as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **24.6.2022** and Second Appeal was filed in the Commission on **18.8.2022** under Section 19 of the Right to Information Act, 2005. The case was last heard on **2.12.2022**.

2. The appellant is absent for the second successive hearing. The respondent PIO, represented by Sh.
