In addition to his submission, the PIO is also hereby given an opportunity under Section 20(1) proviso, thereto, for a personal hearing before the imposition of such penalty on the next date of hearing. He may note that in case he does not file his submission and does not avail himself of the opportunity of personal hearing on the next date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex-parte.

5. Respondent PIO is directed to deal this case on priority basis without further delay as he is already not complying notice/order of the Commission and directions of the First Appellate Authority vide letter no. 666 dated 20.03.2023 to represent this case today, which is received in the Commission vide diary no. 8151 dated 29.03.2023 and taken on record.

- 6. Respondent PIO is directed to supply information within ten days after receipt of this order under intimation to the Commission.

- 8. A copy of this order be sent to the First Appellate Authority is directed to look into the matter and make sure for the compliance of this order.
