**ORDER**

1. This order may be read with the reference to the order dated 03.11.2022 passed by this Bench on the previous hearing.
2. The case has been heard today. Shri Surinder Singh, appellant attends the hearing through cisco webex and states that irrelevant information has been supplied to him and in fact, it is no information.
3. Shri Pankaj Lehri, Junior Engineer attends the hearing through cisco webex and states that point-wise information as well as an affidavit has been sent to the Appellant and also sends a copy of the same on WhatsApp number to the Bench during the hearing itself.
4. The Bench apprises the appellant of the version of the respondent as also of the affidavit filed by the appellant. He, however, expresses dissatisfaction over the information supplied and the filing of affidavit. On the asking of the Bench, the respondent states that the information as available in the official records has been supplied and as such, an affidavit has also been filed to this effect.
5. The Bench observes that the appellant is adamant in not agreeing with the contention raised by the respondent. The Bench, however, on perusal of the reply of the PIO as also the contents of affidavit is convinced that adequate information stands supplied to the appellant.
