ORDER:

1. The RTI application is dated 11.10.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 15.11.2022 and the second appeal was filed in the Commission on 05.01.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. The notice of hearing was issued to the parties for 15.03.2023. Accordingly, the case has been heard today. The appellant has not come present to attend the hearing in person before the Bench or through cisco webex nor any intimation has been given by him in this regard.

3. Shri Pawandeep Singh, Junior Engineer O/o Nagar Council, Nabha has come present to attend the hearing in person and states information has been provided to the appellant vide letter dated 11.01.2023 and again on 13.03.2023 by hand.

4. The appellant is contacted on his mobile phone. He is apprised of the version of PIO. He express satisfaction over the reply of the respondent, however, alleges that this information has been supplied after a lapse of four months.

5. Since, the information stands supplied to the appellant to his satisfaction. No cause for further intervention is left in the matter. However, the PIO is directed to be careful in future and give time bound appropriate response to the public as per time lines prescribed under the RTI Act.

6. In view of the above, the Bench does not feel need for further intervention in the matter. The instant appeal case is **disposed off and closed**. Copies of the order be sent to the concerned parties.
