Order

This order may be read with reference to the previous order dated 18.10.2022.

- 2. The representative of the respondents reiterates the statement given on the previous hearing. She states that the complaint dated 13.4.2022 in question was received on 4.5.2022 through whatsapp from Head Office and the same was received physically on her seat on 16.5.2022. She further states that this complaint was clubbed with the earlier complaint of the appellant which was being heard by the Asstt. Commissioner, Complaints. Both the complaints were disposed of and closed after giving the hearing to the parties. She further states that no separate inquiry was done on the complaint dated 13.4.2022. The representative of the PIO has got inspected the concerned file during the hearing. The PIO has sent the noting dated 16.6.2022 along with the order issued on 5.7.2022 which is taken on record.

- 4. After hearing both the parties and going through the case file, it is transpired that complaint dated 13.4.2022 was decided after clubbing with the other complaint at the District level and no action has been taken on complaint dated 13.4.2022 at the Government level. A copy of the noting along with the order so received from the PIO is being sent to the appellant along with the order.
- 5. That no more action is required in this case. Hence this case is disposed of and closed.
