Order

This order may be read with reference to the previous order dated 27.10.2022. The case was adjourned to 23.11.2022. The case was postponed due to administrative reason and fixed for hearing today i.e. 19.01.2023.

2. The appellant is absent today. He has sent an email and informed the Commission that no information has been provided by the PIO.

3. The PIO has sent reply pertaining to point no.1 regarding accreditation letter received from PSEB and CBSE through a letter bearing no. 2078 dated 23.11.2022. The reply so received from PIO is taken on record. The PIO states that Bhartiya Model Sr. Sec. School, Rampurphul has not applied for the accreditation for class 10 and 12. She further states that point no. 1 and 4 is inter related and no information is available pertaining to point. No. 4. A copy of the letter received in the Commission is being sent to the appellant along with the order.

4. The representative of PIO o/o PSEB(Affiliation Branch) states that information sought in point no. 2 is not clear and does not exist in the record as the appellant has sought educational qualification of the Headmaster working in Punjab Board and CBSE Board. She further states that information pertaining to point no. 3 is personal and hence cannot be provided.

5. After hearing the PIOs, the Commission accepts the reply of the PIOs. No more cause of action is required in this case. Hence this case is disposed of and closed. Since the appellant is absent today, liberty is granted to the appellant to contact the Commission within two weeks from issue of this order for submissions, if any.
