**ORDER:**

1. This order may be read with reference to the previous order dated 13.12.2022. The matter was adjourned to 29.3.2023.
2. In today's hearing, the appellant Shri Manjinder Singh states that approximately two years are gone but nothing been supplied to him till date even after the directions of the Commission. He further pleads that penal action may be initiated against the respondent department.
3. Respondents state that requisite information (comprising 1106 pages) is with them and appellant could collect today in the Commission. Respondents submits replies to the Show cause notices issued to them vide letter no. 531 dated 28.03.2023 (O/o RTA, Hoshiarpur) and vide letter no. 958 dated 29.03.2023 (O/o RTA, Jalandhar), which are considered and taken on record. After hearing both the parties and examining the case file, appellant is advised to collect the information (1106 pages) today from the respondent/undersigned Bench within working hours and point out deficiencies, if any, within 7 days to the respondent under intimation to the Commission, failing which it shall be presumed that the information supplied is sufficient and nothing is to comment by the appellant in that regard.
