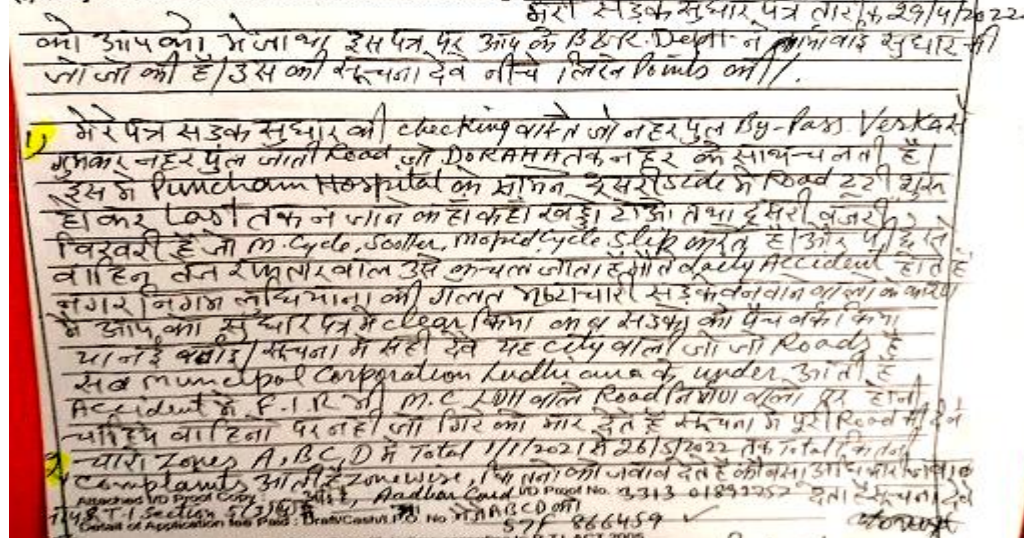

ORDER:

1. The RTI application is dated **26.5.2022** vide which the appellant has sought information:
