Order

This order may be read with reference to the previous order dated 3.10.2022 vide which PIO o/o S.S.S. Board, Punjab was impleaded as a necessary party in this case and the PIO was directed to file the response in respect to the RTI application of the appellant before the next date of hearing. The case was adjourned and was fixed for hearing today.

2. None is present on behalf of the DPI(SE), Punjab. The PIO o/o DPI(SE), Punjab has sent reply bearing no. 261132 dated 30.9.2022 to the Commission which is taken on record. The relevant part of the letter is reproduced below:

- (c) ਇਸ ਸਬੰਧੀ ਸਕੱਤਰ ਸਕੂਲ ਸਿੱਖਿਆ ਜੀ ਵੱਲੋਂ ਜਾਰੀ ਪੱਤਰ ਦੀ ਕਾਪੀ ਇਸ ਪੱਤਰ ਦੇ ਨਾਲ ਨੱਥੀ ਕੀਤੀ ਜਾਂਦੀ ਹੈ ਜਿਸ ਅਨੁਸਾਰ ਉਕਤ ਕਰਮਚਾਰੀਆਂ ਵਿਰੁੱਧ ਕੋਈ ਕਾਰਵਾਈ ਨਹੀਂ ਚੱਲ ਰਹੀ।
