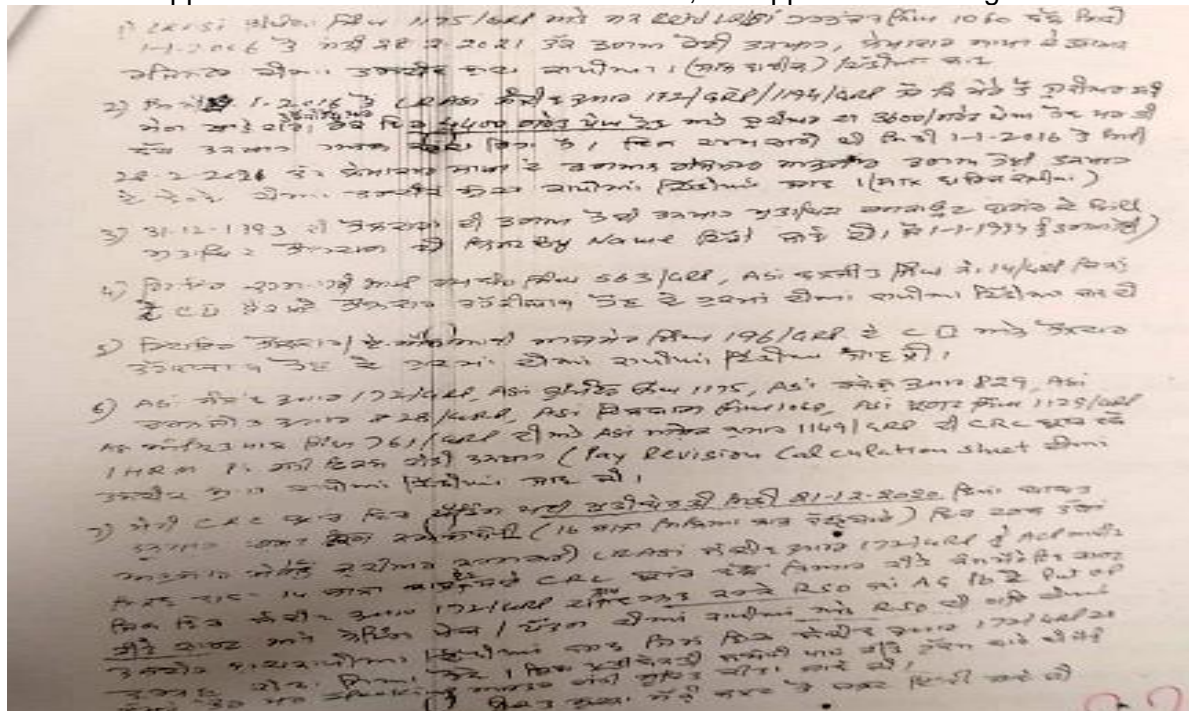

as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **28.5.2022** and Second Appeal was filed in the Commission on **17.8.2022** under Section 19 of the Right to Information Act, 2005. The case was last heard on **2.12.2022**.

2. Both parties are present. As directed at the last hearing on 2.12.2022, the respondent PIO has submitted a written, pointwise reply to the RTI application vide Letter No. 3289 Dated 26.1.2023, along with the requested record pertaining to point nos. 1, 2, 3, 6, and 7. Regarding point no. 4 and 5, the respondent states that the information sought is vague and non-specific and does not seek any particular information by way of number, date etc., so that the requested record can be accessed and provided to the appellant.

3. The respondent PIO, represented by Head Constable, Gurpreet Singh, has requested the Commission that the applicant be requested to move an application regarding point no. 4 and 5, along with details by way of number, date etc., following which all efforts will be made to provide the information to him. The appellant has agreed to move such an application, where after the respondent PIO is to provide the information, as available in the record.

4. This Appeal Case is accordingly **Disposed of**.
