**ORDER:**

1. The RTI application is dated 23.05.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 28.06.2022 and second appeal was filed in the Commission on 26.8.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). Notice of hearing was issued to the parties for hearing through CISCO WEBEX on 8.12.2022 i.e. today
2. In today's hearing, both the parties are present.
3. The appellant states that the respondent department has supplied irrelevant and incomplete information. He further states that RTA, Hoshiarpur and Jalandhar have supplied the information then why the RTA, Patiala not ready to give the information.
4. The respondent states that the sought information relates to the Smart Chip Company, which is being called from the concerned company.
5. The court while listening both the parties, directs the respondent PIO to collect/get the information from the Smart Chip Company through an email and supply the same to the appellant within ten days after receipt of this order.
6. Appellant is advised to go through the information, once he had received and point out ambiguity within seven days in writing to the respondent PIO with a copy to the Commission, failing which it will be presumed that he has nothing to say in this regard.
7. With aforesaid directions, matter is adjourned for further hearing on **28.03.2023 at 11:00 A.M. through CISCO WEBEX application.** Copy of the order be sent to the parties.
