ORDER:

1. This case may be read with the reference to the previous order dated 04.05.2023.
2. In today's hearing, appellant states that information is still pending from the respondent PIO.
3. Respondent PIO is absent without any intimation to the Commission.
4. After examining the case file, it is observed that appellant filed RTI application on 23.05.2022 and for non-furnishing the information he filed First Appeal to the First Appellate Authority on 28.06.2022 and second appeal in the Commission on 26.08.2022.
5. Notice of hearing was issued to the parties on 04.10.2022 by the undersigned Bench and was dispatched on 06.10.2022 for hearing on 08.12.2022. It is observed that ample time was there from 06.10.2022 to 08.12.2022 but respondent PIO did not bother to represent this case or for supplying the requisite information. **Respondent PIO was absent on 08.12.2022** and matter was adjourned for further hearing on 28.03.2023, which was postponed and fixed for hearing on 04.05.2023.

On hearing held on 04.05.2023, respondent appeared intimated the Commission that PIO concerned is on medical leave from November 2022 and requested for an adjournment. A final opportunity was awarded to supply the attested copy of requisite information as per RTI application within ten days after receipt of that order and matter was adjourned for today but respondent PIO did not bother to appear today even after issuing the registered post notice and order to him by the Commission. Commission takes a serious view of the casual approach of the Respondent PIO as it leads to wastage of precious time and resources of the Commission.

6. A call is made to the Secretary, RTA, faridkot, Ms. Veerpal Kaur (M: 9988713653), PCS during the hearing and she intimates the Commission that she recently joined the Faridkot office and further requests for an adjournment to go through the matter to resolve the issue accordingly.

7. Respondent PIO is directed to appear along with relevant record on the next date of hearing at Commission positively so that case could be concluded.
